
# CERTIFICATE OF INCORPORATION OF

We, the undersigned, natural persons of the state of Texas, acting or more years of age, all citizens of the State of Texas, acting as incorporators of a corporation under the Texas Non-Profit Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation.

#### ARTICLE I.
